

# Biddy Tarot Network Reader Agreement

Congratulations on taking the courageous leap to becoming a Biddy Tarot Network Reader, offering your Tarot reading services, free of charge, in exchange for feedback and experience. This is going to be a wonderful experience!

To ensure a positive experience for you, the client and Biddy Tarot, there are a number of guidelines for you as a Biddy Tarot Network Reader. The following Biddy Tarot Network Reader Agreement clearly outlines these guidelines. By being an active reader of the Biddy Tarot Network, you agree to this Agreement.

## General

The Biddy Tarot Network is owned and operated by Brigit Esselmont ("Biddy Tarot", "I" or "we"). By using the Biddy Tarot Network, you agree to be bound by the Biddy Tarot Network Reader Agreement and to use the Biddy Tarot Network in accordance with this Agreement.

We reserve the right to change the Agreement or to impose new conditions on use of the Biddy Tarot Network, from time to time, in which case we will post the revised Agreement on this website. By continuing to use the Biddy Tarot Network after we post any such changes, you accept the Agreement, as modified.

## Services

You are required to provide free Tarot readings as part of the Biddy Tarot Network. Tarot readings are to be provided by email unless agreed otherwise with the individual client.

You may set your own availability using the Reader Dashboard. If you set your availability to receive Tarot reading requests, you must be able to respond to those requests.

If you are unable to do a reading due to ethical reasons (3rd parties, predictions, etc.), you are strongly encouraged to work with the client to rephrase the question to refocus the reading on something you can comfortably work with. If you are still unable to fulfill the request, please advise your client and seek to reassign the request immediately by posting for help on the private Facebook page or contacting [btn@biddytarot.com](mailto:btn@biddytarot.com) (this is a last resort).

Completed Tarot readings are to be sent to the client within 7 days of receipt.

If you are unable to fulfill the request within the required timeframe, you must advise your client and seek to reassign the request immediately by posting for help on the private Facebook page or contacting [btn@biddytarot.com](mailto:btn@biddytarot.com) (this is a last resort). Failure to do so may result in the termination of your membership with the Biddy Tarot Network.

## Service Quality

The Bidy Tarot Network is intended as a learning environment, therefore there are no strict criteria for the quality of Tarot readings provided. However, it is expected that you will complete each Tarot reading with a high level of professionalism and to the best of your ability.

You may not directly copy material from other sources to include in your Tarot readings (e.g. Tarot card meanings) without the appropriate references.

## Complaints

If a Bidy Tarot Network client lodges a complaint that they have not received their Tarot reading within 7 days, you will receive a warning via email and your profile will be set to "Not Available". You will also have an opportunity to provide a response to Bidy Tarot as to why the complaint was made. If 3 complaints are lodged against you, your membership may be terminated at our discretion.

# Bidy Tarot Network Membership

## 3-Month Membership Payment

Upon sign up to become a Bidy Tarot Network Reader, you will be billed for a 3-month membership. It is an automatic and recurring payment, therefore you will continue to be automatically billed for a 3-month membership every 3 months via PayPal until you cancel your membership.

## 'Old' Members (Members Prior to December 16, 2013)

Bidy Tarot Network Readers who were active members prior to December 16, 2013 ("old members"), were offered the opportunity to remain on the old membership whereby a one-time administration fee was charged. Therefore, there are no recurring membership fees for 'old' members.

'Old' members are entitled to the benefits that were available as at December 16, 2013, but will not be entitled to any new membership benefits offered after this date unless transferring to the new membership model.

'Old' members must remain active members on the Bidy Tarot Network. If an 'old' member does not take at least one reading request within a two month period, membership will be terminated.

## Cancellation and Termination

You can cancel your Bidy Tarot Network membership at any time, either via PayPal or by

emailing [btn@biddytarot.com](mailto:btn@biddytarot.com). You must give at least 7 days' notice in writing to cancel your membership.

Biddy Tarot reserves the right to terminate the Agreement at any time if the Agreement is broken or compromised, with notice to be given in writing.

Upon cancellation of your membership, your recurring payments will cease. No full or partial refunds will be offered. Your profile will be removed and you will not have access to the Reader Dashboard nor the private Facebook group.

## Membership Refunds

There are no full or partial refunds. If you cancel your membership part way through a 6-month period, your membership fee will not be refunded. And if Biddy Tarot terminates the Agreement, no refunds will be provided.

## Compensation

This is a free service therefore you will not receive financial compensation of any kind in return for your Tarot readings on the Biddy Tarot Network. The purpose of the Biddy Tarot Network is to offer you a safe environment to practice your Tarot reading skills in exchange for feedback.

## Non-Disclosure and Non-Solicitation

You shall not disclose to any other person other than a representative of Biddy Tarot at any time either during the term of this Agreement or following the termination, any confidential or proprietary information pertaining to Biddy Tarot, including but not limited to client lists, contacts, financial data, sales data, business opportunities, models or plans, or trade secrets.

Furthermore, you agree that during the term of this Agreement and for a period of one year following the termination of this Agreement, you shall not directly solicit or attempt to solicit any clients from the Biddy Tarot Network. If a client contacts you on their own accord, you retain the right to provide private services to that client. You can also include a small, discreet link to your website in your email signature.

## Privacy and Confidentiality

You must keep all client information, including but not limited to names, emails, questions, or Tarot readings, confidential and private.

You may not publish client readings, feedback or testimonials without the express permission of the client.

## Services for Third Parties

You retain the right to provide services similar to the Services to other individuals, businesses or the general public, so long as it is in accordance with the Non-Disclosure and Non-Solicitation terms.

## Conduct

### Reader Conduct

It is expected that you will behave in a manner that is professional and ethical. Abuse of any kind will not be tolerated and is likely to end in the termination of your Bidy Tarot Network membership.

### Client Conduct

Clients are also expected to conduct themselves in an appropriate manner. If a client is abusive or threatening towards you, or is abusing the system by not adhering to the rules outlined on the request page, you can report them to [btn@biddytarot.com](mailto:btn@biddytarot.com). Depending on the circumstances, we may, at our discretion, ban them from future use of the Bidy Tarot Network.

## Training and Supervision

The Bidy Tarot Network is a self-managed and self-guided platform for learning to read Tarot for others. No direct training or supervision is provided.
